ORDER OF AN EXECUTIVE OFFICER CLOSED FOR TENANT ACCOMMODATION PURPOSES ORDER TO VACATE

And To:	All Occupant(s) of the following Housing premises: 9912 107 Street - Basement
RE:	The housing premise located in Fort Saskatchewan, Alberta and municipally described as: 9912 107 Street, Lots 21 and 22, Block 26, Plan O - Basement

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

a. The windows in two bedrooms located in the basement do not meet egress requirements. The windows within the basement bedrooms did not meet emergency egress requirements (openable area of the window was less than 3.8 ft2). Window measured less than 15 inches for the height and 28 inches for the length of the window. There is one bed in each basement bedroom that may be used for sleeping purposes.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

a. The windows in two bedrooms located in the basement do not meet egress requirements. The windows within the basement bedrooms did not meet emergency egress requirements (openable area of the window was less than 3.8 ft2). Window measured less than 15 inches for the height and 28 inches for the length of the window. There is one bed in each basement bedroom that may be used for sleeping purposes. This is in contravention of Section 3(b)(ii) of the Minimum Housing and Health Standards, which states that "Windows referred to in section 3(b)(i) shall provide unobstructed openings with areas not less than 0.35 m2 (3.8ft2), with no dimension less than 380 mm (15")."

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed for Tenant Accommodation Purposes**.

NOW THEREFORE, I hereby ORDER and DIRECT:

- 1. That the occupants vacate the basement premise on or before October 22, 2024. Beds, mattresses and sleeping materials must be removed from the basement.
- 2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Install emergency egress windows within the bedroom basement space that will provide an unobstructed opening of at least 3.8 ft2.
- 3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain closed for tenant accommodation purposes.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
